### **GRAND SAGA ANNOUNCES 10% DISCOUNT ON TOLL FEES AND DISTRIBUTES FREE TOUCH N' GO CARDS**

**KUALA LUMPUR, 17 FEBRUARY 2015 – TALIWORKS CORPORATION BERHAD (“TCB” or “the Group”)** through its subsidiary Grand Saga Sdn Bhd, (“**Grand Saga**” or “**the Company**”) today made two announcements in conjunction with the 2015 Chinese New Year celebration. The Company which currently holds the concession for the Cheras-Kajang Highway will also be offering a 10% discount on toll charges for a period of 24 hours beginning at 12.01 a.m. on 19<sup>th</sup> February 2015.

The card which normally costs RM10, will come with a preloaded value of RM2.00 and will be issued at the toll plaza beginning on 18<sup>th</sup> February 2015 until stocks last.

Speaking about the announcement, A.Rajasolan, Senior General Manager of Grand Saga shared, “We recognise that a great number of Malaysians travel our roadways, especially during festive seasons, and have implemented this initiative to help ease their burden. On behalf of Grand Saga, I would like to wish all our highway users a prosperous and cheerful Chinese New Year, urging that you practice patience and care while driving on the road.”

The discount along with the distribution of the free Touch N' Go cards, is part of the Company's CSR policy and is aimed at easing the burden of all Cheras-Kajang Highway users during important festivals and celebrations. Grand Saga is committed to promoting and undertaking good CSR practices that have a positive and enduring impact on all their key stakeholders, towards their vision of becoming a formidable and respected service provider in the infrastructure sector. By distributing free Touch N' Go cards, the Company also hopes to promote a greater usage of electronic tolling, thus minimising traffic congestion at the toll plazas.
