### **GRAND SAGA ANNOUNCE 10% DISCOUNT ON TOLL FEES AND GRAND SEPADU ANNOUNCE DISTRIBUTION OF FREE TOUCH ‘N GO CARDS IN CONJUNCTION WITH CHINESE NEW YEAR CELEBRATION**

**KUALA LUMPUR, 4 February 2016** – Taliworks Corporation Berhad (“TCB” or the “Group”) through its subsidiary, **Grand Saga Sdn Bhd (“Grand Saga”)**, which currently holds the concession for the Cheras-Kajang Highway, today announce a 10% discount on toll fees and its joint venture company, **Grand Sepadu (NK) Sdn. Bhd. (“Grand Sepadu”)**, which holds the concession for the New North Klang Straits Bypass Expressway (“**NNKSB**”), announce distribution of free Touch ‘n Go cards in conjunction with the Chinese New Year Celebration. Grand Saga will be offering a **10% discount for Class 1 vehicle on toll charges for a period of 24 hours beginning at 12.01 am on 8<sup>th</sup> February 2016**. Meanwhile, Grand Sepadu will be distributing **1,000 Touch ‘n Go cards**, with a total value of RM14,000. The card which normally cost RM10.00 comes with a **preloaded value of RM4.00** and will be given away free at the toll plaza cash lanes beginning on **5<sup>th</sup> February 2016 (Friday)** until stocks last.

Speaking about the announcement, Mr. A. Rajasolan, Senior General Manager added that “This is a little initiative in line with our CSR theme, ‘Serving People, Aiding Communities’ and wished all Malaysians celebrating the Lunar New Year, ‘Gong Xi Fa Cai’ and happy holidays.” He also reminded all motorists to drive safely during the festive period.

Grand Saga’s Cheras-Kajang Highway is one of the first four-lane dual carriageway in Malaysia which stretches at 11.5km from the Connaught Interchange, Cheras to Saujana Impian, Kajang. The 17.5km NNKSB Expressway which links Port Klang to Klang town is operated and managed by Grand Sepadu.
